**My family and I:** 1) agree to show respect for other's parenting and homeschooling styles; 2) agree to show respect and not cause harm to the personal property of others; 3) understand TPA does not allow the use or possession of illegal drugs, alcohol, firearms or other weapons at TPA sponsored group functions; 4) understand TPA does not tolerate illegal acts of any kind; 5) understand TPA does not tolerate the misbehavior of children which is harmful to other persons or their property and which goes continually uncorrected by the parent; 6) understand that TPA does not tolerate intentional threatening or insulting comments among group members; 7) agree to not share information contained in the directory with ANYONE outside the TPA membership; 8) understand that all activities our children participate in require parental supervision. We understand that we can make arrangements with another parent in the group to provide that supervision. Unless specifically stated, none of the activities my children will be participating in are a "drop-off" situation; 9) understand that if there are any concerns pertaining in any way to the operations of TPA that I/we will bring it to the attention of a Board or Operating Officer Team Member and request time at the next Board or Operating Officer Team meeting to discuss the issue; and 10) understand that TPA expects its members to be in compliance with Washington State education Law; 11) understand that the Teaching Parents Association/TPA name and logo are reserved for the official use of the association.
